INVITATION TO BID

The Local Government Unit of Pilar, through the *General Fund 2013* intends to apply the sum of *Seven Hundred Fifty Thousand Pesos (\$750,000.00)* being the Approved Budget for the Contract (ABC) to payment under the contract for the *Improvement of ABC Hall of LGU-Pilar, Sorsogon.* Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Local Government Unit of Pilar now invites bids for the *Improvement of ABC Hall of LGU-Pilar, Sorsogon*. Completion of the Works required is Fifty Five (55) Calendar Days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Local Government Unit of Pilar and inspect the Bidding Documents at the address given below from November 25 (9:00 a.m. – 4:00 p.m.) – December 10, 2013 – (9:00 a.m. – 10:00 a.m. only).

A complete set of Bidding Documents may be purchased by interested Bidders from *November 25 (9:00 a.m. - 4:00 p.m.) - December 10, 2013 - (9:00 a.m. - 10:00 a.m. only)* at the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount stated below:

For projects below \$101,000.00 - 1% of ABC or Five Hundred Pesos (\$500.00), whichever is higher

For projects \$\pm\$101,000.00 - \$\pm\$500,000.00 - 0.5% of ABC or One Thousand Pesos (\$\pm\$1,000.00), whichever is higher

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) provided that bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

Bids must be delivered to the address below on or before *December 10, 2013 - 10:00 am at BAC Office, 2nd Flr., Municipal Bidg., LGU, Pilar, Sorsogon.*All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Local Government Unit of Pilar reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
